

COCKLE FISHERY



At their meeting on 17 September the Members of KEIFCA will be discussing proposals for the review of current, and the development of future, cockle fishery management not only within the TECFO but across the whole District.

GOODWIN SANDS MARINE CONSERVATION ZONE




KEIFCA is required to develop management to protect *Sabellaria reefs* and circalittoral reefs at this site.

Our patrol vessel Nerrisa has spent time this summer carrying out side-scan sonar surveys to look at species distribution in the area to allow proportionate management to be developed.
