IFCA VESSELS UPDATE



Workboat Code 3 applies to commercial vessels under 24 metres in length carrying up to 12 passengers. It builds on previous editions of the Workboat Code, reflecting advances in safety

management, risk assessment, and evolving industry needs and came into force in December 2023 All our vessels will be required to transition to this Code and Members will be provided with details of the work being undertaken to ensure they

comply.

SAVING SEAGRASS

Seagrass are the only flowering plants able to live in seawater and pollinate while submerged. They are found in shallow waters and often grow in large groups giving the appearance of terrestrial grassland – a lush underwater In Essex, there are two types of meadow. and dwarf common eelgrass eelgrass.


